## **1 RULES**

- 1.1 The regatta will be governed by the rules as defined in the ISAF Racing Rules of Sailing 2013-2016.
- 1.2 In addition the Racing Rules 2014 of the Austrian Sailing Association, the Principle Sailing Instructions of the Austrian Sailing Association, the Sailing Instruction of the YCP and the Notice of Race will apply.
- 1.3 The Austrian anti doping regulations will apply.
- 1.4 Appendix P will apply.
- 1.5 If there is a conflict between languages the English text will prevail.

## **2 ADVERTISING**

- 2.1 Boats may be required to display advertising chosen and supplied by the organizing authority.

## **3 Eligibility and Entry**

- 3.1 The regatta is international open to boats of the 420, Laser, Laser Radial, Zoom8 and Optimist class(es). The person in charge shall have a valid driving license of the OeSV. Members of other national federations shall have an adequate driving license of their national authority. Each crew member shall be a member of a club, affiliated to a national authority of the ISAF. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of € 1.500.000.- per event or the equivalent.
- 3.2 Eligible boats may enter by completing the attached form and sending it, together with the required fee, until 09.05.2014 to Yachtclub Podersdorf; St.Christophorus 9, A-7141 Podersdorf am See, or using the online entry form at [www.ycpodersdorf.at](http://www.ycpodersdorf.at).

## 5 Restrictions

The following restrictions on the number of boats apply:

**420; Laser Radial, Zoom8, Optimist** : a minimum entry rate of 10 boats.

If the minimum entry rate is not reached, the regatta can be cancelled.

420 er: € 85.-

Optimist: € 40.-

## 8 Measurement Controls

Each boat shall have a valid measurement certificate. In addition measurement controls but no first measurement are sheduled on 23.05.2014 (8-10 Uhr).

## **11 Courses**

Courses to be sailed will be described in the sailing instructions.

Target time: 50 min.

Target Time Zoom 8; Optimist: 40 min.

## **12 Races sheduled**

### **Class Laser, Laser Radial, 420, Zoom8:**

8 races are sheduled.

0-4 races: no discard

5-8 races: one discard.

Minimum number of races for valid austrian championship: 4 races

Minimum number of races for valid ranking regatta: 3 races.

Scoring System: Low-Point-System (WRS Appendix A).

### **Class Optimist:**

4 races are sheduled.

0-3 races, no discard

4 races, one discard.

Scoring System: Low-Point-System (WRS Appendix A).

## **13 Coach Boats**

A limited number of coach boats is approved. coach boats require a permit of the YCP.

Coach boats may enter by sending the type of the boat, the national registration ID Number and the name of the driver until 09.05.2014 to Yachtclub Podersdorf; [regatta@ycpodersdorf.at](mailto:regatta@ycpodersdorf.at).

Coach boats must be marked by yellow flags, available at the Race Office. A deposit of 50.- Eur is required.

## **14 Berthing**

Boats shall be kept in their assigned places

## **15 Radio Communication**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## **16 Prizes**

Prizes and title will be awarded as defined in Wettfahrtordnung OesV 2014.

Regardless of this regulation, prizes will be awarded for the first 3 places of each class and the Sail Centre 2014 ranking of the 420 class.

## **17 Disclaimer of Liability**

The responsibility for the decision of the person in charge to participate in a race or to continue with it is solely with him, to that extent he also takes the responsibility for his crew. The helmsman is responsible for the qualification and the correct nautical conduct of his crew as well as for the suitability and the transport-safe condition of the registered boat. In cases of Force Majeure or on grounds of administrative orders or for safety reasons the organizer is entitled to make changes in the realisation of the event or to cancel the event. In these cases there does not exist any liability for compensation of the organizer to the participant. In case of a violation of obligations that do not constitute primary respectively material contractual duties (cardinal obligations), the liability of the organizer, no matter because of which cause in law, for material and property damages of all kinds and their consequences that arise to the participant during or in connection with the participation in the event resulting from a conduct of the organizer, his representatives, servants or agents, is restricted to damages that were caused wilfully or grossly negligent. When a violation of cardinal obligations occurs, in cases of simple negligence the liability of the organizer is limited to foreseeable, typically occurring damages.

To the extent that the liability for damages of the organizer is excluded or restricted, the participant also relieves the staff – employees and representatives, agents, servants, sponsors and individuals who provide or drive salvage, safety or rescue vessels or assist with their use - from the individual liability for damages, as well as also all other individuals who were instructed to act in connection with the realisation of the event. The effective racing rules of the ISAF, the class rules as well as the regulations of the Notice of Race and the Sailing Instructions are to be complied with and are expressly recognised. The austrian law apply.

## **18 Insurance**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000.- € per event or the equivalent.
